Pension Revision Update

February for UFT Retirees

Starting in February, about 2,000 members will see an increase in their retirement allowance payments as a result of the 2023 contract for the United Federation of Teachers (UFT). UFT members who retired since September 2022 were reviewed for this revision.

CSA revisions will follow

The Council of School Supervisors & Administrators (CSA) also recently ratified a new contract, in December of 2023. When TRS receives updated salary information for employees covered by the new agreement, we will evaluate those members for a possible retirement allowance revision.

New Laws Impact TRS Members

Three recently enacted New York State laws affect TRS and other City pension funds:

- Under Chapter 711/2023, members of TRS, NYCERS, or BERS who have dual employment associated with a different City retirement system are no longer restricted to membership in their first system. Members may "suspend" membership in the first retirement system and join the second retirement system.
- Chapter 716/2023 affects the benefits payable after the death of a member who is over age 60. The law lowers the existing age-based reductions, resulting in an increased benefit for eligible beneficiaries. The change applies for members who die(d) after June 30, 2021.
- Chapter 717/2023 concerns transfers of membership between New York City and New York State retirement systems. In certain situations, it requires that a member's pension reserves be transferred to the new retirement system along with the member contributions.

TRS has begun work to implement these laws and will publish more information as appropriate.
