

**INSTRUCTIONS***PLEASE READ CAREFULLY*

- Please file this form if you wish to repay one or more of your outstanding Qualified Pension Plan (QPP) loans with a lump-sum payment. *Tiers III, IV, and VI members only:* You may also file this form if you wish to repay the outstanding balance on a defaulted QPP loan. (If you wish to repay one or more of your outstanding and/or defaulted Tax-Deferred Annuity (TDA) Program loans, you must file a "TDA Loan Repayment Request Form" (code LO11t).)
- *Please note:* Internal Revenue Service (IRS) regulations no longer allow outstanding loan balances to be combined with new loans. Instead, any new loan requested would be treated as a separate loan, and each loan balance would be subject to the interest, applicable insurance charges, and repayment terms in effect when the loan is issued.
- In Part B, you must provide your membership status, indicate whether you want to repay an outstanding and/or defaulted QPP loan(s), and provide all applicable loan numbers. If you are retiring, please provide your effective retirement date in the space indicated.
- Upon receipt of this form, TRS will calculate the total amount(s) required for a lump-sum repayment(s) of your QPP loan(s) and send you an explanatory letter(s). Please note that, if you wish to repay an outstanding and/or defaulted QPP loan(s) in conjunction with your retirement, TRS would calculate your repayment balance as of your planned retirement date.
